

Tarrant County College Certified Nurse Aide Program Information Packet

Approved by the Texas Department of Health and Human Services

COURSE DESCRIPTION:

The Certified Nurse Aide (CNA) Training Program is a 100-hour course. It is a noncredit certification program that awards CEUs upon successful completion of all course work and clinical hours. This entry level healthcare program prepares participants to provide patient-centered care for residents at long-term care facilities. Participants are eligible to take the nurse-aide state examination upon completion of the program. To become certified and listed in the CNA Texas Registry, participants must complete the 100 hours, successfully pass the written and skills performance requirements.

The program has two courses that total 100 hours; attendance, adherence and completion of all classes and assignments is mandatory to be eligible for the State examination.

Application Process:

- Submit online application and all supportive documents
- Receive notification of acceptance. Acceptance does not guarantee a student a seat in the program. Registration is first-come, first-served.
- Register, pay tuition and obtain parking pass and textbook.

Certified Nurse Aide: Application Packet Checklist

The below supportive documents must be submitted online with the application to be considered for the CNA program.

- ♦ Must be 18 years of age or older
- ♦ High School Diploma, GED, or College Transcript. If diploma or GED is a non- U.S. document, you must have it evaluated by: International Academic Credential Evaluators, Inc. Denton, TX

- ♦ Valid unexpired Driver's License or photo ID (military or U.S. Passport).
- ♦ Signed Social Security card
- ♦ Current American Heart Association BLS for Healthcare Providers card.
- ♦ Hepatitis B series of 3 boosters or positive titer
- ♦ MMR series of 2 boosters or positive titer, unless born prior to 1957, then 1 dose or positive titer.
- ◆ Tdap one dose within the past 10 years.
- ◆ TB Skin Test with negative reading within 12 months of course completion date or Chest X-ray for TB screening.
- ♦ Varicella 2 doses unless first dose is prior to age 13, report of a positive titer or documented date of illness.
- ♦ Flu Shot for current season.
- ♦ COVID -19 Vaccine
- ♦ Criminal Background Castle Branch (prior to attending clinical Mandatory)
- ♦ 10-panel Drug-Screening: Castle Branch (prior to attending clinical Mandatory)
