### Student Financial Aid Services

Additional guidelines for the grants are listed below.

### Texas Educational Opportunity Grant Program (TEOG) Eligibility Requirements are:

- Have a *Statement of Student Eligibility* form on file with the Student Financial Aid Services Office
- Have not attempted more than 45 semester credit hours (1<sup>st</sup> year award)
- Enroll in at least six credit hours each semester
- Registered with Selective Service or be exempt
- Complete 67 percent of hours enrolled with a 2.0 GPA the first year you receive the grant
- Complete 75 percent of hours enrolled with a 2.5 GPA for renewal award in all subsequent years
- Not be concurrently receiving a Texas Grant
- Not have completed an Associate Degree or higher
- Not have attempted more than 75 total semester hours (including accepted transferred hours)

A student may be eligible for the TEOG funds if they have indicated they have been **convicted** of a felony or an offense under Chapter 481, Health and Safety Code (Texas Controlled Substances Act), or under the law of another jurisdiction involving a controlled substance as defined by Chapter 481, Health and Safety Code if they have received:

1. A certificate of discharge by the Texas Department of Criminal justice or a correctional facility **OR** completed a period of probation ordered by a court **AND** at least two years have elapsed from the date of receipt or completion; or
2. A pardon had the record of the offense expunged from the person's records, or otherwise been released from the resulting ineligibility to receive a grant under this subchapter.

If you meet one or more of the above-mentioned resolutions and you can provide supporting documentation, follow the instruction provided below.
